## NIST/EAC Future of Voting Systems Symposium – February 26-28, 2013 Panel: "Exploring Alternative Methods and Goals for Federal Testing and Certification"

**ABSTRACT:** This panel will explore alternative methods of product certification and discuss the pros and cons of incorporating these into the certification of voting systems.

**Moderator:** Merle King is Associate Professor Emeritus and the Executive Director of the Center for Election Systems at Kennesaw State University in Kennesaw, Georgia. An active researcher in election administration, Professor King is the 2005 recipient of the National Association of Secretaries of State Medallion Award for his work in Georgia elections. King is a mediator and is a frequent invitee to the Election Assistance Commission's roundtables as moderator and discussant. Together with his colleagues at the Center, King has led the development of one of the nation's best resources for election administration support. The Center for Election Systems provides voting systems technical support to the Georgia Office of the Secretary of State and to the 159 county election supervisors in the Georgia. At the NASED Conference in January 2013, he was elected NASED's President for the second time. He served as Chair of the Board of Advisors to the U.S. Election Assistance Commission from 2006-2008. This Board was created by the Help America Vote Act to review guidelines and studies before they are issued by the Election Assistance Commission.
