

The MIP list contains cryptographic modules on which the CMVP is actively working. For a module to transition from Review Pending to In Review, the lab must pay the NIST Cost Recovery fee. The validation process is a joint effort between the CMVP, the laboratory and the vendor and therefore, for any given module, the action to respond could reside with the CMVP, the lab or the vendor. This list does not provide granularity into which entity has the action. If you would like more information for a specific cryptographic module or its schedule, please contact the vendor.
